REQUIRED MATERIALS

DESCRIPTION

Exploratory Field Experience provides education majors with an opportunity to participate in 20 hours of guided inquiry and exploration of the career of teaching in a supervised elementary setting. Students will gain experience in observing children and professional educators while assisting the supervising teacher with designated tasks and activities.

COURSE OBJECTIVES

Upon completion of this course students will be able to:

- A. Recognize and analyze factors that influence the teaching profession
- B. Explore the personal decision to become a teaching professional
- C. Examine and evaluate various educational circumstances and conditions in schools
- D. Analyze and compare personal viewpoints toward education in real-world contexts

CULTURAL RELEVANCY

Cultural relevancy will be addressed in this course through teaching methodologies, discussion of educational issues relevant to Indian education, and through strategies modeled and utilized by the instructor.

Student Objectives:

- 1. Students will examine the inter-relatedness of education issues described in class and how these issues relate to the cultures of the Salish and Kootenai Tribes.
- 2. Students will apply information from the course in their work with children from similar and diverse cultures.

CRITICAL THINKING

This course will encourage critical thinking skills by having students apply and critique information.

Student Objectives:

- Students will apply information observed in classes to the goal of adding to their knowledge of teaching practices.
- 2. Students will participate in written reflections that utilize critical thinking skills such as problem solving skills, self-evaluation techniques and comparing information to cultural issues:
- 3. Students will explore their own attitudes and preconceptions regarding teaching.
- 4. Students will compare and contrast educational scenarios observed in the field.
- 5. Students will problem solve various factors pertaining to the application of material presented in other education coursework.

COURSE REQUIREMENTS

- A. Participate in no less than twenty (20) hours of observation and reflection in Pre-K-12 (K-8) preferred) classroom-based learning environments.
- B. Complete all required written documentation of these observations.
